In the event that work requires operatives to work less than 2m from each other, they must wear a three layer face covering. No physical contact will take place Non-essential physical work that requires close contact between workers must not be carried out Work requiring skin to skin contact must not be carried out All other work is planned to minimise contact between workers Re-usable PPE must be thoroughly cleaned after use and not shared between workers Single use PPE must be disposed of so that it cannot be reused Holding meetings in open areas where possible. | | | | | | | | | |
